Annual Parish Council Meeting

1. Election of Chair and Vice-Chair

The problem has been reported to Cheshire East Highways. The drain appears not to be blocked, but does appear to be in the wrong place.

- Litter appears to be a problem again in the area around the KFC Clerk will contact the Duchy. Roy Aspinall is also working on the main road
- Bridge House Farm the issue has been reported to the Police and details will be sent to Cllr Edgar
- Fir Tree Cottages it was agreed to establish ownership (TW will send land registration details)
- Village Day 29th June 2019 letter sent to Clerk requesting Parish Council assistance. CH reported on the plans for the day. The Parish Council will be represented on the day and the Council will also cover the costs of insurance and toilets, as previously discussed

10. Borough Councillor's Report

Cllr Edgar attended the meeting and reported that the political control of Cheshire East Council had changed following the election on 2nd May 2019 from Conservative control to Labour/Independent control.

Cllr Edgar also reported that it had been proposed to move from a Cabinet to Committee based system at Cheshire East Council

11. Cheshire East Development Strategy Process

Cllr Wilde reported no significant developments and it was agreed to remove this as a standing item on future agendas.

12. Highway Matters

- It was reported that the 30 mph sign opposite Hungerford Place still needed to be fixed
- Potholes on Radway Green Road opposite Bank Cottage need to be sorted out
- Floods there have been two floods on Engelsea Brook due to blocked gullies on Engelsea Brook Lane. It was also reported that a grid is blocked by the post box and outside Valley Farm
- A500 roundabout issue with road markings not being clear enough has been reported to Highways for England and will be addressed as part of the A500 widening
