4	<b>TERMS OF REFERENCE</b>	<p>The following was agreed: -</p> <ul style="list-style-type: none"> <li>• Meetings would be held quarterly</li> <li>• Meetings would be scheduled, and any correspondence recorded</li> <li>• Any issues raised will be reported individually and reported back to parish councils where relevant</li> <li>• Issues will be dealt with as and when they occur</li> <li>• Information to be received from Cheshire East Council and communicated immediately to contractors and communities</li> <li>• HS2 will be an issue and this group will need to work with other liaison groups where necessary</li> <li>• Agreed to use social media and other channels to collect and disseminate information to communities and others – each parish has various methods in place to do this – communications will be a standing agenda item for meetings</li> <li>• A500 will become a 'live' topic when dates are known, and the intention is to communicate relevant information</li> </ul>
